



| <b>Objective:</b>            | The programme seeks to provide Interns practical exposure and hands-on experience related to various fields of labour and employment, which are the core activities of the VVGnLI. It would help them to develop a better understanding of the various dimensions related to undertaking labour research, generating inputs for labour policy making and organizing capacity building activities. | <b>Eligibility:</b>          | The applicant must be enrolled in the final year of a full-time Law or Management course (Masters or equivalent) relevant to the VVGnLI’s activities. In particular, applicants should be pursuing the following courses:<br>(1) Law graduates pursuing post-graduation in law (LLM) and who have obtained overall 75% and above marks in graduation or ‘A’ grade and above (wherever grading exits);<br>(2) Law students pursuing 5 year integrated law courses and who have obtained 75% and above marks in 10+2 standard or ‘A’ grade and above;<br>(3) Graduate students pursuing Master’s in Business Administration (MBA) and who have obtained overall 75% and above marks in graduation or ‘A’ grade and above;<br>(4) Graduate students pursuing Post-graduate diploma in management (PGDM) and who have obtained overall 75% and above marks in graduation or ‘A’ grade and above;. |
| <b>Duration:</b>             | The duration is two months on a full-time basis at NOIDA.   |
| <b>No. of Seats:</b>         | Fifteen (15)  |
| <b>Tasks to be performed</b> | Each interns would be assigned specific tasks by the Institute related to training, research, publications, consultancy and other activities as per the mandate of the Institute.   |
| <b>Stipend:</b>              | The interns will be entitled to a consolidated stipend of Rs. 8,000/- per month subject to the certification of the competent authority nominated by the Institute. The VVGnLI will not bear any other expenses (such as cost of travel, accommodation, living expenses etc.) during the internships programme, which should be the sole responsibility of the intern or his/her sponsoring institution.  |
| <b>Functional Support:</b>   | The interns will be provided necessary working space, internet connectivity, access to the library and other facilities as decided by the authorities from time to time.  |
| <b>How to Apply:</b>         | Interested applicants may apply online in the format attached with this advertisement. | <b>Placement:</b>                              | Placement of interns will be carried out with the approval of the competent authority of the Institute, keeping in view their suitability as well as requirements of concerned research centres/divisions of this Institute.  |                           |
| <b>Declaration:</b>                            | Interns will be required to furnish to the institute a declaration of secrecy before reporting for the internship.  |                           |
| <b>Closing Date of Receipt of Applications</b> | <b>The closing date has been extended till March 16, 2022</b>   |                           |
